METROPOLITAN AREA EMS AUTHORITY DBA MEDSTAR MOBILE HEALTHCARE BOARD OF DIRECTORS REGULAR MEETING January 25, 2024

The Metropolitan Area EMS Authority Board of Directors conducted a meeting at the offices of the Authority, with some members participating by video conference call pursuant to Section 551.127(c) of the Texas Government Code. V. MONTHLY REPORTS

- A. Chief Executive Officer– Ken Simpson referred to Tab A and informed the Board that we have been working with the City of Fort Worth and JPS on jail invoices and expect both to go before their respective boards or councils in March for approval. Ken offered kudos to Marshall's Office, Fort Worth Police Department, Fort Worth Fire Department, and MedStar on the spectacular job all agencies exhibited during the aftermath of the explosion in Downtown Fort Worth on January 8th; we will be working through after actions reports for the opportunity improvement in future events. Fort Worth Mayor Mattie Parker reached out to all agencies involved and asked them to be represented at the Fort Worth Stock and Rodeo. Ken provided the first interim report from Fitch & Associates to the Board earlier this week. The Ad Hoc Committee will meet on February 6th to dive into some of the financials, governance conversations and models and on February 20th, they will release their final draft report with recommendations and different modeling for different EMS systems.
- B. Office of the Medical Director Dr. Jarvis referred to Tab B and reviewed the new OMD clinical dashboard showing system performance against national benchmarks. Dr. Jarvis provided an update on our operation safe intubation and STEMI care. The next CE will focus on cardiac arrest protocol changes and those protocols are still in development. After research, field testing and market review, we have decided to move the system to use of the Air-Q Supraglottic Airway and system-wide training on the device will be complete as of March 1st. Dr. Jarvis also noted that Fort Worth Fire Department paramedics are completing credentialing at an advanced level.
- **C.** Chief Transformation Officer Matt Zavadsky referred to Tab C and offered kudos to Desiree Partain on her work with community projects.
- **D.** Chief Financial Officer– Steve Post referred to Tab D.
- **E.** Chief Human Resources Officer- Leila Peeples referred to Tab E and informed the Board that we have 25 new hirers starting on Monday which will give us a full staff but are

continuing to recruit due to attrition. Human Resources is preparing for National Cancer Awareness next month to promote awareness, screenings, and prevention.

- F. FRAB Chief Spears informed the Board that Fitch & Associates has made significant data requests from each of the member city FROs. The FRAB is monitoring the Fitch & Associates study and upcoming Ad Hoc meetings. The next FRAB meeting will be held on February 15th.
- G. Operations Chris Cunningham referred to Tab G and offered kudos to Operations on handling winter weather activity this month and are preparing for February. A new field schedule will go live this month -- Heath Stone and the team did an excellent job demand and staffing. We have met our priority one response times at the 85th percentile standard for the last three months. Our Communication Center has maintained their ACE accreditation for the first quarter and the IT Department and Paranet have completed the network refresh project.
- H. Compliance and Legal- Chad Carr referred to Tab H.
- I. EPAB Dr. Commons informed the Board of the EPAB meeting this afternoon and offered kudos to Dr. Jarvis and the Office of Medical Director for ensuring our patients receive the best care possible.

RECOMMENDATION:

It is recommended that the Board of Directors approve the response time reporting metric at the 90^{th} percentile.

DISCUSSION:

In December of 2016 the EMS System Performance Committee recommended reporting response times at the 85th percentile and set the response time goals at that percentage. There have been several discussions over the past few years about reporting to the 90th percentile.

With discussion from FRAB and some discussion from the EMS System Performance Committee there is support to report response times at the 90th percentile. It is understood that capacity will have to be added to the system to decrease the response times but moving the reported metric to the 90th percentile will allow us to be more consistent with what is reported nationally.

For these reasons it is recommended the Board of Directors approve reporting response times at the 90th percentile.







Month Performance – December 2023


































CA 05: Utstein Survival %





Airway 01: First Pass Intubation Success without Hypotension or Hypoxia




Percentage of EMS responses originating from a 911 request for who receive a successful advanced airway placement on first attempt without documented hypotension or hypoxia during the peri-intubation period

Airway 02: Adequate Oxygen Saturation Achieved Before Intubation Procedure




Percentage of intubation procedures performed during an EMS response originating from a 911 request in which adequate patient oxygen levels were achieved prior to intubation procedure.

Airway 03: Waveform Capnography Airway Device Monitoring




Percentage of successful advanced airway procedures performed during an EMS response originating from a 911 request in which waveform capnography is used for tube placement confirmation and monitoring.

STEMI 02: Aspirin Administration for STEMI




The percentage of EMS patients aged 18 years and older transported from the scene with Aspirin administration for suspected heart attack.


STEMI 04: Pre-Arrival Notification ≤ 10 Minutes for Positive STEMI Heart Attack ECG



Stroke 01: Evaluation of Blood Glucose for Patients with Suspected Stroke




The percentage of EMS patients aged 18 years and older transported from the scene with suspected stroke for whom blood glucose was evaluated during the EMS encounter.






The percentage of EMS patients aged 18 years and older transported from the scene with a suspected stroke for whom a stroke screen was performed and documented during the EMS encounter.

Stroke 03: Stroke Alert for Suspected Stroke



Stroke 04: Documentation of Last Known Well for Patients with Suspected Stroke




The percentage of EMS patients aged 18 years and older transported from the scene with suspected stroke for whom Last Known Well was documented during the EMS encounter.



Asthma 01: Administration of a Beta Agonist for Asthma


Percentage of EMS responses originating from a 911 request for patients with a diagnosis of asthma who had an aerosolized beta agonist administered.


Percentage of EMS responses originating from a 911 request for patients with symptomatic hypoglycemia who received treatment to correct their hypoglycemia.

Percentage of EMS responses originating from a 911 request for patients with primary or secondary impression of respiratory distress who had a respiratory assessment.


Respiratory-02: Oxygen Administration for Hypoxia



Trailing 12-Month (TTM) Performance


Percentage of EMS responses originating from a 911 request for patients with hypoxia during which oxygen is administered.

Seizure 02: Patients with Status Epilepticus Receiving Intervention




Percentage of EMS responses originating from a 911 request for patients with status epilepticus who received benzodiazepine aimed at terminating th.

Syncope 01: ECG Performed for Syncope Patients




Percentage of EMS responses originating from a 911 request for patients with syncope during which a 12-lead (or greater) ECG is performed.

TBI-01: Clinical Assessments for Patients with Traumatic Brain Injury





Trauma 01: Pain Assessment of Injured Patients




Percentage of EMS transports originating from a 911 request for patients with injury who were assessed for pain.

Trauma 03: Effectiveness of Pain Management for Injured Patients




Percentage of EMS transports originating from a 911 request for patients whose pain score was lowered during the EMS encounter.

Alternate Payment Models & Expanded Services

- Agreement in concept reached with Cook Children's Health Plan on high utilizer program.
 - MIH payments using CPT codes, like Cigna.
 - Data sharing hurdle resolved.

<u>Texas Ambulance Supplemental Payment Program (ASPP)</u>

- Joining Public Consulting Group (PCG), Dallas Fire, Houston Fire, Ausin/Travis County EMS, and others in a meeting with Texas Medicaid to discuss status of Texas' ASPP program on 3/1/24.
 - Texas Medicaid adopted our suggestion for a supplemental payment program based on Average Commercial Reimbursement vs. service delivery costs.
 - Much more equitable model that could benefit MedStar vs. cost-based model, due to our low cost of service provision.
 - Texas filed State Plan Amendment (SPA) with CMS to make the change.
 - Amendment caught up in delayed approval process, likely due to ongoing federal audits of FD cost reports to determine appropriateness of attributable expenses.

<u>Homeless High-Utilizer Program</u>

- With MAEMSA Board approval, implementation plan in the works with reps from MedStar, OMD, JPS, MHMR, TCHC, and FWFD.
 - Working through HIPAA compliant method for care coordination.

<u> EMS Performance Measures – National Joint Position Statement</u>

- Co-Chairing an initiative to create a Joint Position Statement encouraging use of performance measures for EMS, beyond response times.
 - Building on the collaborative effort on the 2021 Joint Position Statement encouraging the reduction of light and siren responses.
 - 15 national associations, including the International City/County Management Association are participating.
 - Position paper emphasizes clinical, experiential, operational and financial metrics as primary performance measures.
 - The final draft is planned to be approved by the 15 association reps at our 2/15/24 meeting.

<u>National EMS Staffing Task Force</u>

- Leading an effort to create guidance document for appropriate staffing levels for EMS response based on 911 call types and acuities.










Mobile Integrated Healthcare Program Outcomes

Metropolitan Area EMS Authority dba MedStar Mobile Healthcare Finance Report – January 31, 2024

The following summarizes significant items in the January 31, 2024, Financial Reports:

Statement of Revenues and Expenses:

Month to Date: Net Income for the month of January 2024 is a gain of \$157,866 as compared to a budgeted loss of (\$67,256) for a positive variance of \$225,122. EBITD for the month of January 2024 is a gain of \$549,822 compared to a budgeted gain of \$311,104 for a positive variance of \$238,718.

- Patient contact volume in January ended the month at 103% to budget.
- Net Revenue in January is \$373K over budget or 107% to budget. The main drivers of the variance are MedStar billed 3.4% more Commercial Insurance trips than expected.
- Total Expenses ended the month 103% to budget or \$148K over budget. In January, MedStar incurred additional expenses in Salaries and Wages of \$12K, Health Insurance Claims of \$238K. The total of all other line-item expenses is below budget by (\$102K).

Year to Date: EBITD is \$2,250,517 as compared to a budget of \$2,140,337 for a positive variance of \$110,179.

The main drivers for this variance are YTD patient encounters are 101% to budget and YTD net revenue is 103% to budget equating to a YTD positive variance to budget for Net Revenue of \$653,586. Year to date expense is 103% to budget or \$579,709 over budget. The main driver for the overage in expense is the following line items are over budget: Salaries and OT is above budget by \$192K, Benefits and Taxes is above budget by \$703K and Facility and Equipment Maintenance is above budget by \$20K. The total of all other expense lines is below budget by a total of (\$337K) for the year.

Key Financial Indicators:

- Current Ratio MedStar has \$7.64 in current assets (Cash, receivables) for every dollar in current debt. (Goal: a score of \$1.00 would mean sufficient current assets to pay debts.)
- Cash Reserves The Restated Interlocal Cooperative Agreement mandates 3 months of operating capital. As of January 31, 2024, there are 4 months of operating capital.
- Accounts Receivable Turnover This statistic indicates MedStar's effectiveness in extending credit and collecting debts by indicating the average age of the receivables. MedStar's goal is a ratio greater than 3.0 times; current turnover is 4.69 times.
- Return on Net Assets This ratio determines whether the agency is financially better off than in
 previous years by measuring total economic return. An improving trend indicates increasing net
 assets and the ability to set aside financial resources to strengthen future flexibility. Through
 October, the return is 1.0%.

MAEMSA/EPAB cash reserve balance as of January 31, 2024, is \$475,470.69.

Ambulance 911 Response Times






Response times measured from phone answer time to arrival on scene



Response times measured from phone answer time to arrival on scene




